Please read the following information about the project so that you can decide whether you would like to take part in this research. Please feel free to ask any questions you might have about your involvement in the project. You can also talk to someone you trust, like a family member or friend, before deciding if you want to participate.

Participation in this research is voluntary. If you do not wish to take part, you do not have to. If you decide to take part and later change your mind, you are free to stop at any time, and you would not need to give any explanation for your decision to stop participating.

If you decide to take part, you will be asked to sign a Consent Form and will be given a copy of that signed form and this Participant Information Sheet to keep. Your decision whether you take part, or not to take part, or to take part and then withdraw, will not affect your relationship with The University of Queensland, Thread Together Australia, or Anglicare Southern Queensland.

If you need any additional in understanding the Participant Information Sheet and Consent Form, the research assistant will be able to explain these to you.

### **What is the research about?**

Anglicare Southern Queensland (Anglicare) is doing an evaluation of Brisbane's Thread Together Clothing Hub and Mobile Wardrobe.

### **Who is doing the research?**

This study is conducted by researchers from Anglicare Southern Queensland and The University of Queensland (UQ). ### **How can you participate?**

#### ***Interview***

If you were a leader or key staff member in setting up Brisbane's Thread Together Clothing Hub and Mobile Wardrobe, we'd like to hear what it was like for you to be part of this project! We will invite you to talk about your experience. The interviews will be scheduled for up to 60 minutes. The interviews will take place at your usual workplace at Anglicare Southern Queensland, Level 15, 31 Duncan Street, Fortitude Valley; this will therefore not incur additional travel or parking beyond usual travel costs.

### **Do you have to participate?**

If you choose not to participate in this evaluation, no one will mind. You can also pull out at any time, including before, during or after participating in the interview. We will only use what you have contributed to the research until then.

### **What are the possible benefits of taking part?**

There will be no clear benefit to you from your participation in this research. This research and evaluation project is done in partnership with Anglicare to assist the continued improvement of Thread Together's service delivery. This research and evaluation will therefore contribute to improving services for socially disadvantaged people in Brisbane.

### **What are the possible risks of taking part?**

We don't think you will come to any harm because of this research, but if you do feel distressed, there will be people and/or services available to help. While providing information you may share stories or remember experiences that either remind you of or cause you to experience feelings of distress or discomfort. If this happens, you are welcome to take a break, or pull out without needing to provide an explanation. It is entirely up to you to decide what experiences you would like to share. You can choose not to answer interview questions you find distressing. If you are feeling distressed, please let the project team know.

We will record the interviews. If you like, you can check the written transcript. We will remove all details that might give away who you are. Any information obtained in connection with this research project that can identify you will remain confidential.

By signing the Consent Form, you consent to Anglicare and UQ collecting, using and (where applicable) disclosing your information as set out in this Participant Information Statement and the Consent Form. Information obtained in connection with this project will be retained and disposed of in accordance with relevant University of Queensland policies and State and National regulations. ### **What will happen to the information about me?**

All personal information collected about you will remain confidential. Given the small number of participants or any rare experiences you may share, it might not be possible to guarantee complete anonymity.

Any information obtained during the evaluation research project is subject to inspection (for the purpose of verifying the procedures and the data) by the relevant authorities and authorised representatives of The University of Queensland, or as required by law. Designated University individuals (data stewards or custodians) may also have access to the information for the purposes of ensuring long term retention and disposal. By signing the Consent Form, you authorise release of, or access to, this confidential information to the relevant research personnel and authorities as noted above.

### Personal Information

The personal information collected for this research project includes: demographic details, and information from the interview.

Collection – Your personal information is collected for the purpose of evaluating Thread Together and its social impact in the community amongst different groups.

Use – Your personal information will be used for the purpose of the research project and any other purpose described in this Participant Information Sheet and the Consent Form.

Storage and security – Your personal information will be maintained confidentially by ensuring appropriate access and security is applied to the research project data. This will be accessed by authorised research staff, authorised staff of UQ (for the purposes of managing data holdings) and third parties as described in this Participant Information Sheet and the Consent Form.

Disclosure – Your personal information will only be disclosed in a manner consistent with this Participant Information Sheet and the Consent Form. This will remain confidential and will not be disclosed to a third party without your agreement, or as required by law.

You have the right to request access to the personal information about you that is collected and stored by the research team. If you are seeking to update or correct any information, it is recommended that you liaise with the research team in the first instance (see contact details at the end of this information sheet).

### **What happens next?**

We anticipate that the results of this evaluation research project will be published and/or presented in a variety of forums. In any publication and/or presentation, information will be provided in such a way that you cannot be identified, except with your express permission.

We will keep all data and transcripts safely stored on a password-protected server at Anglicare Southern Queensland, with a backup on the UQ server, and only the researchers involved in the study will have access to them. Data will be retained in accordance with UQ's Research Data Management policy.

The collected data may be used again for secondary/future research. Identifiable data will not be used in this way without your permission. The consent form will describe situations where collected data may be used again.

### **What will happen if I decide to withdraw?**

Your participation is voluntary and you are free to withdraw without needing to provide an explanation. This will not impact your relationship with Thread Together, Anglicare, or UQ.

If you decide to withdraw, we will not collect additional data or information from you. Any data, samples and information already collected may be retained as described in this Participant Information Sheet and the Consent Form to ensure that the results of the research project can be measured properly and to comply with relevant regulations.

### **Can I hear about the results of this research?**

If you would like to stay up to date about the results of this research, you will have the opportunity to include contact details (separately from your responses to the questions).

The research team aim to produce published academic papers on this topic (books and journal articles), academic presentations on this topic (talks, teaching, conferences), and online research webinars , and an advocacy campaign that uses the report to share stories about the operations and impact of Brisbane’s Thread Together.

You will also be able to access public-facing reports relating to this evaluation that will be produced by Anglicare Southern Queensland, Thread Together (Australia), Anglicare Australia, or other related social services organisations.
